



## 2017 Healthy Steps Wellness Program

### **Medical Effective 1/1/17 (applies to employees and covered spouses/partners)**

1. Complete Well-Being Assessment (WBA) by 12/5/16 to earn the Healthy Rewards Rate through 2/28/17
  - a. Complete WBA through the Healthy Steps Wellness portal
2. Complete Health Screening between 1/1 & 1/31/17 to earn the Healthy Rewards Rate through 7/31/17
  - a. Health Screening can be completed at an onsite event (if available) or a Quest Patient Service Center (PSC)
    - i. Must schedule for onsite or PSC through the Healthy Steps Wellness portal
  - b. If a Quest PSC is not available in the area, may go to in-network physician (free if coded as preventive care)
    - i. Must download personalized Physician Fax Form on Healthy Steps Wellness portal
3. Earn a program total of 2,200 points by 7/14/17 to earn the Healthy Rewards Rate through 12/31/17
  - a. Receive 1,000 points for completing the Health Screening and up to an additional 1,000 points based on results
  - b. Additional points can be earned through challenges available on the Healthy Steps Wellness portal
4. Earn a program total of 3,500 points by 10/10/17 (no impact on rates, opportunity to win prizes)
  - a. Points can be earned through challenges available through the Healthy Steps Wellness portal

### **Medical Effective 1/2/17 through 5/31/17 (applies to employees and covered spouses/partners)**

1. Complete Well-Being Assessment (WBA) and Health Screening by 6/30/17 to earn the Healthy Rewards Rate through 12/31/17 (default to discounted rate through July)
  - a. WBA can be completed through the Healthy Steps Wellness portal
  - b. Health Screening can be completed at a Quest Patient Service Center (PSC)
    - i. Must schedule for PSC through the Healthy Steps Wellness portal
  - c. If a Quest PSC is not available in the area, may go to in-network physician (free if coded as preventive care)
    - i. Must download personalized Physician Fax Form through the Healthy Steps Wellness portal
2. Earn a program total of 3,500 points by 10/10/17 for the opportunity to win prizes (no impact on rates)
  - a. Receive 1,000 points for completing the Health Screening and up to an additional 1,000 points based on results
  - b. Additional points can be earned through challenges available on the Healthy Steps Wellness portal

### **Medical Effective on or after 6/1/2017 (applies to employees and covered spouses/partners)**

1. Earn the Healthy Rewards Rate through 12/31/2017 (default to the discounted rate)
  - a. No action is necessary; however, employees and their covered spouses/partners can still access the WBA and challenges through the Healthy Steps Wellness portal
